Learn4Life First Aid Training

1. About the Website

(a) Welcome to the Learn4Life First Aid Training (Website). We, Learn4Life First Aid Training own and operate this websites.

(b) The Website is operated by Learn4Life First Aid Training (ABN 25428131377). Access to and use of the Website, or any of its associated Products or Services, is provided by Learn4Life First Aid Training. Please read these terms and conditions (Terms) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.

(c) Learn4Life First Aid Training reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Learn4Life First Aid Training updates the Terms, the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

2. Acceptance of the Terms

(a) You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Learn4Life First Aid Training in the user interface.

3. Registration to use the Services

(a) In order to access the Services, you must first register for an account/or apply through the Website (Account).

If any provision of our Terms is unenforceable or invalid, it will be ineffective to the extent it is unenforceable or invalid and will not affect the enforceability or validity of the remaining provisions.
